3. HAZARDS IDENTIFICATION

MOST IMPORTANT HAZARDS: Mild skin irritant. Severe eye irritant.
SPECIFIC HAZARDS: Mild skin irritant. Severe eye irritant.

4. FIRST AID MEASURES

SKIN CONTACT: Wash off immediately with plenty of water for at least 20 minutes. Wash off with soap and water. Immediately remove contaminated clothing, and any extraneous chemical, if possible to do so without delay.
EYE CONTACT: Rinse immediately with plenty of water also under the eyelids for at least 20 minutes. Remove contact lenses.
INGESTION: Never give anything by mouth to an unconscious person. Prevent aspiration of vomit. Turn victim's head to the side.

5. FIRE FIGHTING MEASURES

SUITABLE EXTINGUISHING MEDIA: Alcohol-resistant foam. Carbon dioxide (CO2). Dry chemical. Dry sand. Limestone powder.
SPECIAL HAZARDS IN FIRE: Incomplete combustion may form carbon monoxide. Downwind personnel must be evacuated. Burning produces obnoxious and toxic fumes.
REQUIRED SPECIAL PROTECTIVE EQUIPMENT FOR FIRE-FIGHTERS: Use personal protective equipment. Wear self contained breathing apparatus for fire fighting if necessary.

6. ACCIDENTAL RELEASE MEASURES

PERSONAL PRECAUTIONS: Use self-contained breathing apparatus and chemically protective clothing. Wear suitable protective clothing, gloves and eye/face protection. Evacuate personnel to safe areas.
ENVIRONMENTAL PRECAUTIONS: Construct a dike to prevent spreading.
METHODS FOR CLEANING: Approach suspected leak areas with caution. Place in appropriate chemical waste container.

7. HANDLING AND STORAGE

HANDLING: TECHNICAL MEASURES/PRECAUTIONS: Emergency showers and eye wash stations should be readily accessible. Adhere to work practice rules established by government regulations. Avoid contact with eyes. Use personal protective equipment. When using, do not eat, drink or smoke.
STORAGE: Keep containers tightly closed in a dry, cool and well-ventilated place.
